The Board was pleased with the Port Hope Police Service's (PHPS) successful delivery of the final year of the strategic objectives outlined in the 2015-2017 Business Plan. The Board worked throughout the year to collect community input and in collaboration with the PHPS to develop the 2018-2020 Business Plan.

In the fourth quarter of 2017 the Ontario Government ushered in a draft of the first major rewrite of the *Police Services Act* in almost 20 years. With this revised legislation there will be a notable shift in police oversight and an increased emphasis on the role of police and municipal government in community safety. The Board has kept abreast of proposed amendments through attendance at consultation sessions and discussion with major stakeholders.

I am proud to present to you my annual report for 2017 for the Port Hope Police Service (PHPS). In this report you will not only find information that is required by statute but also yearly statistics, photographs and data that communicates how integral the PHPS is to the community of Port Hope. In 2017, our staff, both uniformed and civilian, diligently worked to provide a safe and enjoyable community for all of its citizens.

As 2017 came to a close, also our 2015-2017 Business Plan wrapped up as well. I am very pleased to say that the PHPS was very successful in attaining the goals and priorities set out by the community in our plan and that in many cases, we exceeded our expectations. To meet the Plan's priorities of effective service, community engagement and mobilization, organizational excellence and sustainable resource management we strove to change the culture within our organization as we transformed to better meet the challenges of today. These challenges resulted in a reorganization of the PHPS into what it looks like in 2018, with a stronger focus on Community Engagement.

Our police service is actively engaged with many groups, committees, teams, and organizations not only in Port Hope but across Northumberland County. From our partnerships with Rebound Child and Youth Services, to Cornerstone Family Violence Prevention Centre, to all of our schools, the Northumberland Situation Table and Safe Communities, we are bridging gaps and forming partnerships like never before. We are striving to continue this as we work toward the new goals set out in our new Business Plan.


In 2017 we continued to see a high level of calls for service for people experiencing a mental health crisis. Our officers have been professionally trained in de-escalation techniques enabling the vast majority of these calls to be handled in a fashion where hospital services were not required and referrals to the appropriate community support service were utilized as an alternative.

Our Criminal Investigations Branch was involved in a number of sizable investigations in 2017 with one in particular showcasing some fine work. Project Backwood was a collaborative investigation partnering with the Cobourg Police Service and the Ontario Provincial Police which culminated in the seizure of \$36,000 worth of cocaine, crack cocaine, crystal methamphetamine and fentanyl, 2 firearms, 1 Taser and over \$3,000 worth of cash as proceeds of crime. Many criminal charges were laid as a result. Investigations such as this one are most concerning as they illustrate that major and organized crime are indeed present and operating in our community. The PHPS continues to work with our partners in law enforcement and the community at large to ensure that these types of crimes cannot become an everyday occurrence.

I would also like to show my appreciation to our staff who are the ones who are responsible for the frontline work and collaboration that occurs every day in this fine small municipality. Without their extraordinary efforts and dedication it would be impossible to enjoy the fantastic relationship that our service has with this community.

During 2017 I was very happy to work with the Board on the preparation and completion of our new 2018- 2020 Business Plan. I would like to thank them for their continued efforts and dedication to this small service and for their support in allowing us to be successful in implementing not only the 2015-2017 plan, but their support as we meet the new challenges in front of us.



# Significant Events

#### **Human Trafficking case in Port Hope**

A Kingston and Port Hope Police joint investigation has ended with the arrest of an 18 -year-old Quinte West man who was recruiting young Kingston girls as escorts. The joint investigation began when a female victim was able to make contact with her mother through an internet game system. Kingston Police were already involved in the investigation and enlisted the help of the Port Hope Police Service. Members of the Port Hope Police Service attended the west end residence and rescued the female victim. The joint investigation is continuing. The officer in charge of the case in Kingston sent the Chief of Police a letter of appreciation for the efforts and due diligence shown by Port Hope Officers.



### Man facing possession of child pornography charges

A 60 year old Port Hope man has been arrested for possession of child pornography. On the 13th of April 2017, as a result of a Police investigation, members of the Port Hope Police, along with Durham Regional Police and Cobourg Police executed a search warrant at the accused's west end residence. Police seized computers and other storage devices. The accused is further charged with accessing child pornography and making child pornography available. He was held in custody for a bail hearing.



# Significant Events

#### **Project Backwood**

On the 29th of September 2017 in the early morning hours the Ontario Provincial Police Organized Crime Enforcement Bureau, Community Street Crime Unit, Tactical Response Unit and Emergency Response Unit executed simultaneous warrants in the Grafton and Colborne area.

From the Grafton residence Police seized approximately 9 ounces of individually wrapped packages suspected to be cocaine, crack cocaine, crystal meth and fentanyl, 360 grams of marihuana, 366 assorted prescription opiates, \$3,100 CAD. Officers also located on the property a large marihuana grow (221 mature plants) that was being guarded by two individuals in a tent who were in possession of two firearms, a 20 gauge shotgun and a 22 caliber rifle.

10 people were taken into custody and after an investigation 5 were held for a bail hearing, 2 were released on a promise to appear and 3 were released unconditionally with no charges.

The estimated value of the drugs, not including the value of the plants that were eradicated from the property, was \$36,000.00. Charges include possession of controlled substances for the purposes of trafficking, unauthorized possession of firearms, production of marihuana, possession of a prohibited weapon, and possession of property obtained by crime.

#### Mental Health Response

There was an 8% increase in mental health calls in 2017 from 2016. Officers are trained in de-escalation techniques; the incidents in 2017 concluded with 68 % of the calls being successfully de-escalated without any injuries to civilians and officers. Port Hope Police continues to work with community partners to provide help to those that need it.



There were 0 fatalities in 2017. Reported motor vehicle collisions were down in 2017 by **15%** from 2016.









# Collisions Involving Pedestrians Total Incidents: 3 | Total Parties: 3



#### **Budget**



#### 2017 Budget Highlights

The 2017 Port Hope Police Service (PHPS) budget highlights are based on preliminary internal statements as external audited year end financial statements were not finalized.


**Revenue:** In revenue, PHPS posted \$146,945 against a budget of \$182,570. The decrease in revenue was primarily related the full transfer from reserve not yet being completed for operating capital.

**Expenses:** In total 2017 expenses were \$4,204,129 compared to a budget of \$4,384,345; these numbers do not include the debenture amounts. PHPS currently has a surplus of \$146,591. Some of the areas that contributed to this surplus was the savings in salaries and benefits and no extraordinary expenses were incurred during the year.

**Capital:** In 2017 capital expenditures for projects totaled \$114,000, which were for police vehicles, vehicle technology, body armour and speed display. All capital projects were funded through the municipal policing reserve. The funds in this reserve come from police service screening revenue.

**Conclusion:** Overall as at December 31, 2017 the PHPS internal year end is showing an estimated year end operating surplus of \$146,591 based on the approved budget of \$4,401,283 with expenses of \$4,204,129, revenue of \$146,945 and a contribution to municipal policing reserve of \$189,852 from Screening.


### **Budget**



#### Screening:

Port Hope Police Service as a business service has a number of clients for which third party criminal record checks are done. In 2017 Screening posted revenues of \$401,849 against expenses of \$207,358 which resulted in an estimated transfer of \$194,491 to the municipal policing reserve. This transfer was \$39,924 above the budgeted amount. Monies from the municipal policing reserve are used to fund police capital items such as police cruisers.

#### **Public Complaints**

The Port Hope Police Service is committed to handling complaints against police in a professional manner for both the individual complainant and the subject police officer. Three officers are committed to investigating public complaints. As required under the Police Services Act ,Part V, investigators for the Port Hope Police Service are the Inspector in charge of operations, the Staff Sergeant in charge of the Criminal Investigations Unit and a Front Line Sergeant. The Inspector is the liaison with the Office of the Independent Review Director.
